

COMPREHENSIVE SEXUALITY EDUCATION (CSE) -ADOLESCENT REPRODUCTIVE HEALTH (ARH) CONVERGENCE PILOT IMPLEMENTATION

Republic Act (RA) No. 10354 titled Responsible Parenthood and Reproductive Health (RPRH) Act of 2012 mandates the DepEd for an age-and development-appropriate reproductive health education and a supportive school environment. RA No. 11166 titled The Philippine HIV and psychosocial support and counseling in learning institutions for the development of positive health and promotion of values and behavior pertaining to reproductive health. Executive Order 141 s. 2021adapts agencies to address the root causes of the social issue.

In response to the republic acts, DepEd Order (DO) No. 31 s. 2018 or the Policy Guidelines on the Implementation of the Bureau of Curriculum Development focusing on the integration of Education (CSE) was released through the reproductive health concepts in the curriculum. In addition, DO No. 28, s. 2018 or the Policy and Guidelines on Oplan Kalusugan sa Department of Education (OK sa DepEd) with the Adolescent Reproductive Health (ARH) Support Services—School Health Division. The program focuses on the reproductive health concerns and basic health services are provided for









CONVERGENCE PILOT IMPLEMENTATION

Republic Act (RA) No. 10354 titled Responsible Parenthood and Reproductive Health (RPRH) Act of 2012 mandates the DepEd for an age- and development- appropriate reproductive health education and supportive school environment. RA No. 11166 titled The Philippine HIV and AIDS Policy Act the development also calls for and provision support and counseling in learning institutions development of positive health and promotion of values and behavior pertaining to reproductive health. Executive Order 141 s. 2021adapts teenage pregnancy as a national priority and mobilizes key government agencies to address the root causes of the social issue.

In response to the republic acts, DepEd Order (DO) No. 31 s. 2018 Implementation the Policy Guidelines on the of the Comprehensive Sexuality Education was (CSE) released through the Curriculum Development focusing on the integration reproductive health concepts in the curriculum. In addition, DO No. 28, s. 2018 or the Policy and Guidelines on Oplan Kalusugan sa Department of Education (OK sa DepEd) with the Adolescent Reproductive Health (ARH) as one of its flagship programs was issued under the Bureau of Learner Support Services- School Health Division. The program focuses on the supportive school environment where facilities for information on adolescent reproductive health concerns and basic health services are provided for learners and the school community.

To further strengthen the implementation of both programs and establish a referral pathway from schools to community health service providers, the CSE-ARH Convergence was launched by the DepEd, Department of Health (DOH), Commission on Population and Development (POPCOM), and supported by UNFPA- CHSI for the CSE roll-out and USAID ReachHealth for the ARH implementation.

This memorandum being issued is to provide information on the CSE-ARH Convergence Pilot Implementation for SY 2021-2022.

- The convergence shall be implemented by the designated CSE-ARH Convergence Group (CGW) from an existing Adolescent Health Technical Working Group (TWG) at the regional level (e.g. RPRH-Regional Team, Regional Implementation Population Executive Board Regional Adolescent Health Development WG). The convergence group shall coordinate or facilitate the key activities. For the Department of Education, the designated ARH and CSE Focal Persons in the Region, selected Schools Division Offices and priority schools shall collaborate with the government and non-government partners together with the Local Government Units (LGU) as part of the Convergence Working Group. The Department of Health and the Commission on Population and Development shall issue memorandum for the convergence activity with the Adolescent Health Development (AHD) Program Managers as Convergence Focal Persons.
- 2. The Regional TWG shall draft and facilitate a Terms of Reference (TOR) Document outlining the roles and responsibilities of key stakeholders (DepEd, Center for Health Development, POPCOM, Department of Social Welfare and Development, LGUs, Pilot Schools, Civil Society Organizations, Private Sector) in the implementation of the CSE-ARH Convergence Activities. To facilitate the local discussion, please see Annex 1 for the Roadmap and Checklist of Activities and Annex 2 for the sample TOR.
- 3. Regional TWG shall identify and select possible LGU Convergence Sites and Pilot Schools based on the selection criteria on Annex 3. Three (3) schools per region selected from different divisions shall be included in the pilot implementation. For regions with more than three (3) schools identified, resource mobilization with partners and sharing of local funds shall be applied.

Table 1 lists the targeted divisions based on the teenage pregnancy rates, CSE pilot areas, and initial consultations. The final list of divisions and schools shall be forwarded by the Regional TWG and submitted to arh@deped.gov.ph on or before November 30, 2021, together with the accomplished school readiness checklist on Annex 3.

- 4. In the absence of an existing Information Service Delivery Network (ISDN) or Health Care Provider Network (HCPN) Directory in the locality, members of the TWG shall map, create, and disseminate the information in the selected LGU and pilot school sites. Otherwise, updating and the dissemination of ISDN or HCPN Directory shall be commenced by the TWG. Mapping shall be guided by Annex 4.
 - 5. The TWG shall also map and review the following:
 - A. existing adolescent reproductive health communication, promotion, and training materials in the region
 - B. available channels for dissemination of materials
 - C. training provided for the School Health Personnel, CSE Teachers, Learners or Peer Educators, Parents/Guardians, School Administrators, and Health Facility-Based Service Providers.

Mapped materials shall be used to conduct appropriate activities for the school to promote adolescent reproductive health, including health service delivery, during the pandemic. Annexes 5 and 6 are attached for the mapping of materials and training.

6. Filled out forms in the annex shall be submitted to the National Technical Working Group for CSE-ARH via https://bit.ly/CSE-ARHConvergence with the corresponding target completion dates indicated in Annex 1. Monitoring and evaluation activities shall be conducted by the National CSE-ARH Working Group with the local adolescent health program focal persons of the DepEd, DOH and POPCOM.

- 3. The Bureau of Learner Support Services- School Health Division shall download funds to the regional offices, subject to approval, for the implementation of the convergence activities, including but not limited to the conduct of meetings, workshops, orientations and/or creation and dissemination of CSE-ARH materials in the selected divisions and priority schools. Guidelines for the utilization of fund shall be issued. It is recommended that BARMM allocate funds for the same purpose, charged against local funds. Funds may be augmented by partners and other sources.
- 4. Details of the Orientation Training for the CSE-ARH Convergence shall be announced through a separate memorandum.
- 5. Conduct of these activities shall consider the current "new normal" setup (e.g., no face-to-face classes, schools may remain physically closed for learners, learners are at home), as well as the overall COVID-19 response of the Department.
