1. The Department of Education (DepEd), through the Bureau of Learner Support Services-School Sports Division (BLSS-SSD), shall conduct the **National Invitational Sports Competition (NISC)** as announced through an Office Memorandum dated March 21, 2022 signed by Undersecretary Revsee A. Escobedo.

To ensure the effective and successful conduct of the NISC, the BLSS-SSD constituted the members of the various working committees and officiating officials for the seven sports who shall serve in the said National Invitationals (see enclosure).

All concerned are enjoined to authorize the participation of DepEd personnel enlisted in the enclosure to serve as technical officiating officials for each of the seven sports and perform games-related administrative tasks during the NISC.

4. DepEd personnel who will serve as technical officiating officials and perform game-related administrative work shall secure an official travel authority from their respective stations. Vaccination cards or DOH-issued vaccination certificates and a medical certificate (fit to work) must be presented upon registration.

7. Travel expenses to be incurred by BLSS-SSD and non-DepEd personnel, and technical officiating officials relative to their participation to the NISC shall be charged against the 2022 Physical Fitness and School Sports Fund subject to the usual accounting and auditing rules and regulations. Meanwhile, meals, accommodation, supplemental allowance, and other related expenses shall be shouldered by the host DepEd division offices.
