

SUBJECT : **Data Collection on DepEd Public Senior High Schools (SHS) that will Offer the Technical-Vocational-Livelihood (TVL) Track on School Year (SY) 2016-2017**

DATE : April 12, 2016

1. In line with the implementation of the SHS program in SY 2016-2017, the Department of Education (DepEd), in consultation with the Technical Education and Skills Development Authority (TESDA), is considering the possibility of engaging Technical-Vocational Institutions (TVIs) for the joint provision of various TVL specializations in select DepEd public SHS. Under a joint provision scheme, the DepEd public SHS will offer the core and applied track subjects while qualified TVIs will offer the specialized track subjects.
2. In this regard, the Office of the Assistant Secretary for Curriculum and Instruction will assess the progress of DepEd public SHS that will offer TVL specializations and therefore require the submission of the following information:
  - a. Projected enrolment per TVL specialization;
  - b. Availability of TVL workshop(s);
  - c. Availability of TVL tools and equipment;
  - d. Availability of teachers for the TVL specializations; and
  - e. Availability of accessible TVIs that can offer the needed TVL specializations.
3. An electronic data collection tool (in Microsoft Excel file format) will be emailed on April 13, 2016 to the Regional SHS Coordinators for immediate distribution to the Schools Division SHS Coordinators.
4. The Regional SHS Coordinators, with the approval of the Regional Director, shall submit the filled-up electronic tool containing the consolidated data of the entire region no later than April 27, 2016 to [jabin.landayan@deped.gov.ph](mailto:jabin.landayan@deped.gov.ph) and [keven.galanida@deped.gov.ph](mailto:keven.galanida@deped.gov.ph).
