Subject: **CORRIGENDUM FOR THE MEMORANDUM
REGARDING THE BRIGADA ESKWELA SA
MARAWI BATCH 2 and 3 IMPLEMENTATION**

In light of the signed memorandum circular dated 21 February 2018 regarding the implementation of the Brigada Eskwela sa Marawi Batch 2 and 3, there are changes to specific details of the previous memorandum due to procurement concerns thereby limiting the number of participants for batches 2 and 3. For this purpose, the following details are advised:

 - iv. Schools Division Superintendents (SDS) and Assistant SDSs of Marawi City Division along with the school heads of the aforementioned 17 schools and other schools that will be cleared to open classes; and,
 - v. DRRMS personnel.

- i. SDSs and Regional Directors (RD) of twin/pair Mindanao ROs and DOs;
 - ii. Eight (8) representatives from the Youth Formation Division of the Central Office; and,
 - iii. Updated list of select Disaster Control Group (DMG) members, Baguio Teachers' Camp personnel, and Administrative Service personnel (see Annex C).
