6. Create a plan of action in implementing inclusive education programs in school.

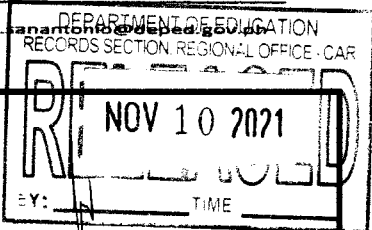

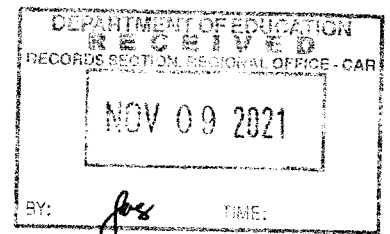
