DESIGNATION OF DEPED REPRESENTATIVES TO INTER-AGENCY BODIES, BOARDS, COUNCILS, AND COMMITTEES

- Involvement of all stakeholders in decision-making, policy-making and operations is essential in addressing complex societal problems and achieving sustainable results.
- In the spirit of good governance and partnership, various government agencies and other institutions convene in inter-agency bodies, boards, councils, and committees which serve as platforms for sharing experiences, building conscisus, and accelerating dialogue on emerging issues.
- With the new management and direction under the current administration, there is a need to update the designations of undersecretaries, assistant secretaries, and central office directors to bodies, boards, councils, and committees where DepEd has membership and participation.
- Related thereto, and pursuant to the authority of supervision and control of the Department vested in the Secretary by Executive Order No. 292 otherwise known as the Administrative Code of 1987 and by Republic Act No. 9155 titled "Governance of Basic Education Act of 2001," new and/or reaffirmed designations shall be instituted as indicated in the enclosure.
- The aforementioned designations, however, shall not preclude the Secretary from exercising the functions delegated to the DepEd representatives. Moreover, alternate representatives shall decisions pertaining to their representation in the body/board/committee/council assigned to them. They shall also submit to the Secretary regular reports on their attendance to meetings relative to their designations.
- 6. All other issuances inconsistent with this Order are hereby repealed of modified accordingly.
- 7. This Order shall take effect immediately upon its issuance. All affected supervising undersecretaries are directed to coordinate among themselves, facilitate orderly transitions, including those of the affected officers in their respective strands, and submit a summary report thereof to the Secretary.

All affected supervising undersecretaries are directed to coordinate among themselves, facilitate orderly transitions, including those of the affected officers in their respective strands, and submit a summary report thereof to the Secretary.
