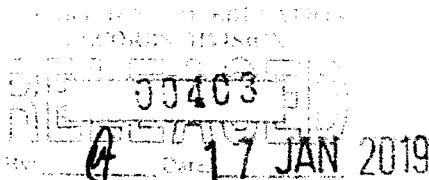

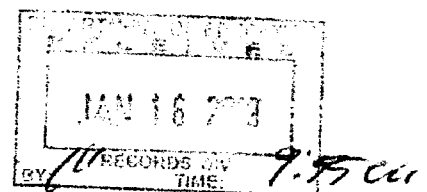
- a. Coordinate with the DepED Employee Associations Coordinating Office (DEACO) for alignment of the program design with the DepED priority programs and initiatives;
