

The total percentage of Sub-SARO releases represent only 48.11% of the total allocation of projects approved for procurement by the different Implementing Units (IUs). Further, it will be noted that the Authority to Procure for these projects were given as early as October 2018 (Batch 1) and June 2019 (Batch 2).
