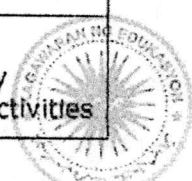
**Subject: TENTATIVE SUSPENSION OR DEFERMENT OF**  
**PROCUREMENT ACTIVITIES FOR BEFF AND GABALDON**  
**PROJECTS WITH AUTHORITY TO PROCURE (ATP)**

This refers to the Department of Budget and Management (DBM) National Budget Circular No. 580 dated April 22, 2020 on the **“Adoption of Economy Measures in the Government Due to the Emergency Health Situation”** specifically section 3.1 **stating possible measures for the discontinuance of appropriated programs, activities, and projects**, to fund the operations and response measures related to the COVID-19 emergency situation.

The Office of Undersecretary for Administration (OUA) and the Office of Undersecretary for Finance (OUF) have already issued the Authority to Procure (ATP) to the different Implementing Units (IUs) for various programs, activities, and projects under the Education Facilities Division (EFD) such as the Basic Education Facilities Fund (BEFF)-Repair and Rehabilitation of Schools; BEFF-Electrification Program; and Gabaldon Heritage School Building Program for CY2020.

To comply with NBC 580 s. 2020, the different IUs are hereby advised to **tentatively suspend or defer the procurement of the aforementioned projects until further advice** from the DepEd Central Office. Please refer to the details below:

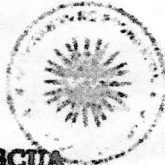


