RNC-CAR Resolution No. 5, s. 2020

**APPROVING TO REITERATE THE RDC RESOLUTION NO. 82 s. 2011 ON THE
ESTABLISHMENT OF LACTATION STATIONS AMONG REGIONAL LINE
AGENCIES OF CAR AND MONITORING ITS IMPLEMENTATION**

WHEREAS, RDC Resolution No 82 s. 2011 pushes for the implementation of RA 10028 or Expanded Breastfeeding Act and calls for the establishment of lactation stations by regional line agencies among other institutions in CAR;

WHEREAS, establishment of lactation stations in government agencies will strengthen the regional advocacy and support for the implementation of exclusive breastfeeding from birth to 6 months and continued breast feeding beyond six months while providing appropriate complementary foods for optimum growth and development of children contributing to improved nutrition in CAR;

WHEREAS, only a few regional line agencies in CAR has established lactation stations based on the Center for Health Development CAR data;


**NOW THEREFORE, ON MOTION DULY SECONDED, BE IT RESOLVED AS IT IS
HEREBY RESOLVED**, that the RNC approves to reiterate the RDC Res. 82, s.2011 on the establishment of lactation stations among regional line agencies of CAR and monitoring of its implementation;

RESOLVED FURTHER, that establishment of lactations stations be monitored through a survey to be conducted by CHD to determine among others, the status of compliance and reasons for non-compliance by regional line agencies.


RESOLVED FINALLY, that results of the survey will be reported during the last quarter RNC meeting.





