



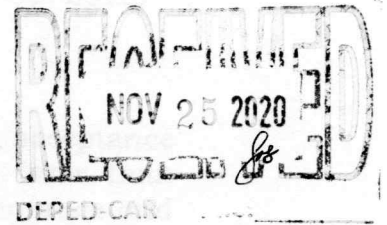

**Subject: EXTENSION OF
SBFP MILK AND NUTRITIOUS FOOD PRODUCTS
IMPLEMENTATION USING FY2019 AND FY2020 FUNDS**

DepEd Order No. 22, s. 2020 or the "Additional Provisions and Amendments to DepEd Order No. 36, s. 2019 (Guidelines on the Implementation of SBFP-Milk Feeding Component)" and DepEd Order No. 23, s. 2020 or the "Operational Guidelines on the Implementation of the SBFP for School Year 2020-2021," have prompted the start of implementation of the School-Based Feeding Program (SBFP) in October this year.

In spite of this, and as a result of the continuous program monitoring on the ground, there are still SDOs who face many challenges in implementing SBFP due to restrictions brought about by COVID-19 pandemic and amplified by the recent strong typhoons that devastated the country. These challenges have affected program coordination with SDO focal persons, the National Dairy Authority/Philippine Carabao Center (NDA/PCC), and the local dairy cooperatives and dairy farmers, not to mention the effect in the movement of goods or supplies and people. Thus, the need to extend the implementation of the program to ensure that the funds will be fully utilized and that all beneficiaries will be served.

The extension of implementation of SBFP Milk Feeding Component is based on the National Budget Circular (NBC) 578 issued on January 6, 2020 specifically in the following Sections:

1. For FY2019 Funds

Section 3.5. Pursuant to R.A. No. 1164, An Act Extending the Availability of the FY2019 Appropriations to December 31, 2020, amending the Purpose Section 65 of the General Provisions of R.A. No. 11260, the GAA of FY2019, the guidelines prescribed under item 3.4.1 and 3.4.2.

2. For FY2020 Funds

Section 3.4.1 The appropriations for the following items under the FY2020 GAA shall be valid for obligation until December 31, 2020;

3.4.1.2 MOOE and other CO items

Section 3.4.2 The completion of construction, inspection, acceptance and payment for infra-related CO shall be made not later than December 31, 2021, while the delivery, inspection, acceptance and payment for MOOE and other CO items shall not be later than June 30, 2021.

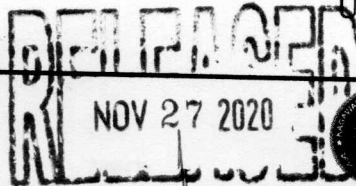
In view of the above, the **SBFP Implementation for FYs 2019 and 2020, both milk and nutritious food products, shall be extended until June 30, 2021.** However, it is hereby reiterated that the FY2019 and FY2020 funds MUST BE obligated until December 31, 2020 pursuant to the conditions mentioned above, while the delivery, inspection, acceptance, and payment shall not be later than June 30, 2021.

In this connection, SDOs are hereby advised to expedite and take the necessary means to fast-track the processing of documents for the prompt obligation of funds until December 31, 2020.
