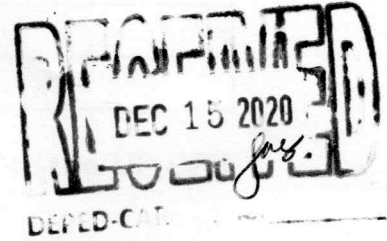

HEALTH AND NUTRITION PERSONNEL**

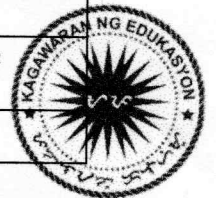

## II. Department of Health (DOH) Academy Platform



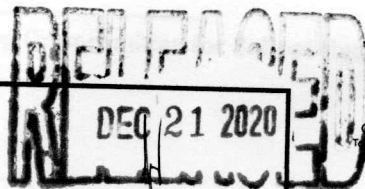
The platform currently offers **CPD-accredited courses on the Universal Health Care and COVID-19.**


