Subject: **ACCESS TO THE REGIONAL/DIVISION DASHBOARDS  
OF THE ELECTION MONITORING APP**

Access to the DepEd Election Monitoring App Dashboard that would show consolidated reports/data at the central, regional and division levels at any given time will be sent today via computer-generated emails to the five members of the Election Task Force (ETF) at ROs/DOS and to all RDs, ARDs, SDSes and ASDSes.

The emails that will be sent will include useful information and instructions on how to access and navigate the dashboards. The near real-time reports/data that can be viewed thru the dashboards are pertinent to one's area of responsibility (i.e. region/division) hence, one can have a picture of the situation and occurrence giving the ETF Members and the RO/DO Officials the ability to either act, coordinate information, and/or escalate matters to concerned personnel or official.

**ETF Chairs may choose to release, instantly or from time to time, to the media and the public portions or all of the dashboard reports, subject to the approval of their respective RDs/ARDs for regional levels, or their respective SDSes/ASDSes for the division levels.** Please be prudent in releasing information, keeping the ones that are deemed highly confidential or might cause panic in confidence or for later release.

**Please expect the computer-generated email from 1:00 pm onwards.** Check your spam folders as well if the email is not displayed in the primary inbox.
