(Guidelines Mother Tongue-Based Multilingual Annex 4 (Guidelines on Mother Tongue-Based Multilingual Education Program Implementation) of DepEd Order (DO) 21, s. 2019 provides that each of the 19 languages currently being used as Medium of Teaching and Learning (MOTL) and as learning areas should have a finalized version of 4 minima which includes a), a locally accepted orthography for writing the language including a primer lesson or primer teacher's guide to systematically on Education for writing the language including a primer lesson or primer teacher's guide to systematically teach the orthography; b), an officially documented vocabulary; c.) a spelling guide or grammar book; and d), a literature or reading materials.
