**BAC RESOLUTION RECOMMENDING AWARD OF PROVISION OF JANITORIAL SERVICES FOR THE DEPED-CAR REGIONAL OFFICE FOR FY 2023 TO MCLEENE PREMIUM PRODUCTS**

WHEREAS, as part of its EARLY PROCUREMENT ACTIVITY, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request CB 2022-10-008 for the, **PROVISION OF JANITORIAL SERVICES FOR THE DEPED-CAR REGIONAL OFFICE FOR FY 2023** with the sum **One Million Two Hundred Thousand Pesos (P 1,200,000.00)** being the Approved Budget for the Contract (ABC).

WHEREAS, on November 16, 2022 the Bids and Awards Committee initiated the opening of bids for the above procurement and the subsequently checked the eligibility and technical component and the Financial Documents as well. The Summary of Bids are as follows:

INC and recommended further that evaluation of their service be done weekly and closely be monitored;
