A. Submission of Quotations

The Requests for Quotation documents can be emailed upon request. Copies are also available at the Procurement Unit of the DepEd-CAR Regional Office from Mondays to Fridays, from 8:00 AM to 5:00 PM.

Quotations and other requirements stated below should be submitted on or before 1:30 PM of October 17, 2024, at DepEd-CAR Regional Office, Wangal, La Trinidad, Benguet.

B. Documentary Requirements

The supplier should submit the following:

- B.1 Duly accomplished and signed **Request for Quotation (RFQ)**, and its attachments, particularly **Section I and Section II.** together with copies of the following:
- B.2 Eligibility Requirements:
 - B.2.1. 2024 Mayor's Permit
 - B.2.2. Certificate of PhilGEPS Registration Red Membership (**Platinum membership need not submit Business Permit**)
- B.3 The Lowest Responsive Calculated Bidder (LRCB) shall submit the following prior to the issuance of a Notice of Award (NOA):
 - B.3.1 Income/Business Tax Return
 - B.3.2 Notarized Omnibus Sworn Statement
- B.4 The Lowest Responsive Calculated Bidder (LRCB) shall submit the following prior to the issuance of a Purchase Order (PO)/Contract:
 - **B.4.1** Performance Security Bond

C. Bid Evaluation and Post Qualification

A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection. A statement either in the Bidder's statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the applicable laws and issuances

A notice to the Single/Lowest Calculated Bidder shall be issued after determining the Single/Lowest Calculated Bidder. **During the Post Qualification (Site Inspection)**, the **LCB shall present the following:**

- a. All licenses, permits, and other documents submitted, such as SEC registration, DTI business name registration, Mayor's permit, TIN, audited financial statements, etc.
- b. An actual sample of the items being offered
- c. Project implementation timeline

NOTE: Failure to submit/present any of the post-qualification requirements on time, or finding against the veracity thereof, shall disqualify the bidder for award. Provided in the event that a finding against the veracity of any of the documents submitted is made, it shall cause the forfeiture of the bid security in accordance with Section 69 of the IRR of RA 9184.

D. Award/Contract

- 1. DepEd-CAR RO shall award the Notice of Award and Purchase Order/Contract to the supplier whose offer is determined to be the lowest calculated and responsive quotation.
- 2. The quotation of the supplier and his acceptance of the Notice of Award and Purchase Order/Contract shall constitute a binding contract between DepEd-CAR RO and the Supplier.

E. Delivery and Inspection

- a. The supplier shall be responsible for the transport of the goods from the store to the DepED-CAR RO.
- b. All goods to be delivered to the DepED-CAR RO shall be free from defects, substandard material, imperfection and other analogous defects.
- c. Only goods with the best quality shall be acceptable to the Department.
- d. All goods found to be with defects, imperfections and poor quality shall be rejected by the Department at any stage of the contract implementation.
- e. Delivery shall be during office hours (8:00-5:00). The Supplier shall not deliver goods on a Saturday, Sunday or Holiday.

- f. Delivered goods at DepED-CAR RO shall be inspected by the Inspectorate Team and accepted by the Asset Management Section Personnel.
- g. The Delivery Receipt (DR) shall be signed by the Asset Management Section Personnel.

F. Liquidated Damages

A penalty of one-tenth of one percent (0.001) of the total value of the undelivered Goods shall be charged as liquidated damages for every day of delay of the delivery of the purchased Goods.

G. Payment

One hundred percent (100%) of the Contract Price shall be paid to the supplier upon completion of services per Contractual agreement/Purchase Order, Certificate of Acceptance provided by the End-user, and submission of the needed documents.

G. DepEd-CAR RO reserves the right to accept or reject any quotation, to annul or cancel the process, and to reject all quotations at any time prior to the award of the Purchase Order/Contract, without thereby incurring any liability to the affected Supplier(s). It has no responsibility whatsoever to compensate the supplier for any expense incurred in the preparation of the quotation nor does it have any obligation to inform the affected Supplier(s) of the reasons for its decision.
