CONTRACT AGREEMENT

THIS AGREEMENT, made this 02 DEC 2024 day of _____, 2024 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

-And-

UNIVERSAL COMMERCIAL CORP with a principal office address at #341 Taylo St. Pasay City represented by its proprietor, **TELESFORO CASTIGO JR.**, herein referred to as the **"SUPPLIER"**

WITNESSETH

The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2024 LEARNING TOOLS AND EQUIPMENT FOR TECHNICAL -VOCATIONAL-LIVELIHOOD (LTE-TVL) WITH 2 LOTS FOR DEPED-CAR - Lot 1** and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

3. The contract duration or completion period shall be within **ninety (90) calendar days upon receipt of Notice to Proceed;**

In consideration for the sum of **ELEVEN MILLION SEVEN HUNDRED NINETY-SEVEN THOUSAND SIX HUNDRED NINETEEN PESOS ONLY (P 11,797,619.00)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid. Attached is a faithful reproduction of the BAC-TWG Arithmetical Evaluation indicating the Description of items, Unit price, and Quantity/unit of *the said goods and services included in this contract made an integral part hereof by incorporation as "Annex A"*.
5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
