THIS AGREEMENT, made this SEP 02 2024 day of Sept, 2024 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

PHILIPPINE RUN HUI TRADING CORP. with a principal office address at 17 Lincoln Street, BRGY. Del Monte, Quenzon City represented by its proprietor, **RICHARD C. GONZALO**, herein referred to as the **"SUPPLIER"**

WITNESSETH
