THIS AGREEMENT, made this

LAMPARA HOUSE PUBLISHING, INC. with a principal office address at 109 Scout Fernandez, Corner Scout Torillo Streets., Barangay Sacred Heart, Quezon City represented by its proprietor, **CARLO BUNAYOS**, herein referred to as the "SUPPLIER"

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly "SUPPLY AND DELIVERY OF REMEDIATION PACKAGES FOR READING PROGRAMS FOR DEPED-CAR-LOT 2 (REBIDDING)" and has accepted a Bid by the "SUPPLIER" for the supply of those goods and services in the sum of FIVE MILLION FIVE HUNDRED THIRTY-FOUR THOUSAND AND ONE HUNDRED PESOS (P 5,534,100.00);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read SUPPLY AND DELIVERY OF REMEDIATION PACKAGES FOR READING PROGRAMS FOR DEPED-CAR-LOT 2 (REBIDDING) and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements:
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

- 3. The contract duration or completion period shall be within sixty (60) calendar days receipt of Notice to Proceed;
- 4. In consideration for the sum of FIVE MILLION FIVE HUNDRED THIRTY-FOUR THOUSAND AND ONE HUNDRED PESOS (P 5,534,100.00) or such other sums as may be ascertained, "SUPPLIER" agrees to provide the goods and services in accordance with his/her/its Bid as follows:
