**CONTRACT AGREEMENT**

THIS AGREEMENT, made this SEP 02 2024 day of 2024, 2024 between:

**DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR)**, a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **“PROCURING ENTITY”**

-And-

**PHILIPPINE RUN HUI TRADING CORP.** with a principal office address at 17 Lincoln Street, BRGY. Del Monte, Quenzon City represented by its proprietor, **RICHARD C. GONZALO**, herein referred to as the **“SUPPLIER”**

WITNESSETH

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;

The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **SUPPLY AND DELIVERY OF MATHEMATICS LEARNING RESOURCES (MANIPULATIVE MATERIALS) FOR THE DEPED-CAR** and construed as integral part of this Agreement, viz:

    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents

- 4. In consideration for the sum of **THIRTEEN MILLION NINE HUNDRED FORTY TWO THOUSAND FIVE HUNDRED PESOS ( P 13,942,500.00)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the following goods and services in accordance with his/her/its Bid:
