**BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROJECT, "REBIDDING OF THE SUPPLY, DELIVERY AND INSTALLATION OF THE LOT TWO OF THE OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED- CAR REGIONAL OFFICE TO CA BLISS ENTERPRISE"**

WHEREAS, the **REBIDDING OF THE SUPPLY, DELIVERY, AND INSTALLATION OF THE LOT TWO OF THE OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE** with the sum of One Hundred Sixty-Six Thousand (P 166,000.00) being the Approved Budget for Contract (ABC) was re-posted in the Philgeps, DEP-ED CAR RO website and bulletin boards continuously from January 11, 2023 to February 1, 2023 at 9:00 A.M. and held its Pre-bid Conference on January 19, 2023 which was attended by prospective bidders;

WHEREAS, after the Pre-bid Conference, **"CA BLISS and INFOWORX"** bought the bidding documents and both were able to timely submit their proposal hence, it was accepted by the BAC;

WHEREAS, during the initial assessment by the BAC, both bidders passed the required eligibility and technical (1<sup>st</sup> Envelope) documents as well as the 2<sup>nd</sup> envelope or were also compliant with the required financial documents, the summary of findings are as follows:

WHEREAS, After the bid opening, the TWG proceeded to Conduct bid evaluation and verified the initial assessment made by the BAC. The TWG submitted their report finding that the above suppliers have complied with all the documentary requirements and the total bid offer of the suppliers are below the ABC as evaluated. Hence, the TWG recommended that CA-BLISS ENTERPRISE shall undergo post-qualification being the lowest calculated bidder.

WHEREAS, the TWG proceeded to conduct post-qualification and visited the office address of CA BLISS ENTERPRISE.

WHEREAS, as per the post-qualification report of the TWG, CA BLISS ENTERPRISE is a legitimate business and is capable of being able to deliver all the supplies in the




procurement project, thus the TWG recommends to the BAC the award to the said Supplier.

**NOW, THEREFORE, on the basis of the foregoing, the BAC resolves as it hereby resolved to:**


1. recommend the award of the contract of the procurement project, "**REBIDDING OF THE SUPPLY, DELIVERY, AND INSTALLATION OF THE LOT TWO OF THE OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED- CAR REGIONAL OFFICE**" in the contract amount P One Hundred Fifty-Six Thousand Two Hundred Fifty (P 156,250.00);
2. recommend for the approval by the DepEd- CAR Regional Director the foregoing findings/ Award.
