**BAC RESOLUTION RECOMMENDING THE AWARD OF THE “SUPPLY, DELIVERY, AND INSTALLATION OF THREE (3) LOTS OF OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE- LOT 3” TO GAKKEN PHILIPPINES INC.**

WHEREAS, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request CB 2022-08-006 for the, **SUPPLY, DELIVERY, AND INSTALLATION OF THREE (3) LOTS OF OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE** with the sum of One Million Pesos (P 1,000,000.00) being the Approved Budget for the Contract (ABC). The ABC for LOT 3 was determined as **Two Hundred Seventy-Nine Thousand Pesos (P 279,000.00)**.

WHEREAS, on December 9, 2022 (Friday) at 2:00 P.M., the DepEd- CAR RO through its Bid and Awards Committee admitted and opened two bid offers that were submitted on time, thus the Eligibility and Financial Documents were subsequently assessed as follows:

WHEREAS, after the detailed bid evaluation and the TWG conducted post-qualification at the Office address of Anjene Industries Inc. at #2 Kendimaster Rd., Bagbaguin City of Meycauayan, Bulacan and subsequently presented the results to the BAC summarized as follows:

1. The registered address is a compound which has several buildings and warehouse yet there was no designated office space and personnel to man the office or do the administrative work. Thus, it does not have regular working days and working hours;
2. The landline number cannot be reached, cellphone calls were not answered, and the response to text messages takes more than 18 hours, thus, they do not have open lines for customer concerns;
3. They declared only one on-going project or contract which is the “Supply and Delivery of Furniture for NEAP- Baguio” that was awarded on September 2, 2022 but have not yet made any delivery to date;

4. During the post- qualification, they mentioned that they have several contracts which is why they were not able to attend to the calls of the TWG that is contrary to the declared statement of on-going government and private contracts which is tantamount to misrepresentation; and
5. The above project is not covered by the purpose of “ANJENE INDUSTRIES INC.” as stated in the articles of incorporation which is limited to business of manufacturing goods such as kitchen wares and to trade the same on wholesale and retail basis.

**WHEREAS, on the basis of the foregoing results, the BAC** recommended to the Head of the Procuring Entity (HOPE) that **ANJENE INDUSTRIES INC.** be post-disqualified and which was subsequently approved by the HOPE;

**WHEREAS,** the BAC directed the TWG to post- qualify **GAKKEN (PHILIPPINES) INDUSTRIES** being the second lowest responsive bidder at their office address at #156 Pantal East, Dagupan City, Pangasinan;

**WHEREAS,** based on the TWG post qualification report, GAKKEN PHILIPPINES INC. is a legitimate business and is capable of the project implementation, hence, recommended for award;

**NOW, THEREFORE, ON THE BASIS OF THE FOREGOING, THE BAC RESOLVES AS IT HEREBY** RESOLVED to recommend to the Head of the Procuring Entity the award of the project “SUPPLY, DELIVERY, AND INSTALLATION OF THREE (3) LOTS OF OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE- LOT 3” to **GAKKEN (PHILIPPINES) INDUSTRIES;**
