**BAC RESOLUTION RECOMMENDING AWARD OF SUPPLY AND DELIVERY OF OFFICE SUPPLIES AND MATERIALS OF THE DEPED-CAR REGIONAL OFFICE FOR THE 1<sup>ST</sup> QUARTER OF FY 2023 TO CATALYST COMPUTER OFFICE EQUIPMENT WHOLESALING**

WHEREAS, as part of its Early Procurement Activity, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request CB 2022-10-010 for the, **SUPPLY AND DELIVERY OF OFFICE SUPPLIES AND MATERIALS OF THE DEPED-CAR REGIONAL OFFICE FOR THE 1<sup>ST</sup> QUARTER OF FY 2023** with the sum **One Million Two Thousand Pesos Only (P 1,002,000.00)** being the Approved Budget for the Contract (ABC).

WHEREAS, the DEP-ED CAR Regional Posted the Invitation to Bid in the Philgeps, DEP-ED CAR RO Website and bulletin boards continuously from October 24, 2022 to November 16, 2022 at 2:00 P.M. and the bid opening was held on November 16, 2022 at 2:100 pm at the SNC Bldng, DepEd- CAR Regional Office which was attended by prospective bidders on site;

WHEREAS, after declaring that the bid documents submitted by the five bidders have “Pass as Read”, the bid documents were turned over to the BAC-TWG for detailed evaluation;

WHEREAS; after the conduct of detailed bid evaluation, the BAC-TWG found that 347 School Office Supplies INC., CATALYST COMPUTER OFFICE EQUIPMENT WHOLESALING, ESM LEARNING ENTERPRISE; JSCG ENTERPRISE, OPC and KANON GENERAL MERCHANDISE were compliant as to the Legal and Technical Envelope submitted;

WHEREAS, on the financial documents submitted, the BAC of decided as follows:


