CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 05 2022 day of _____, 2022 between
DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

-And-

COPYLANDIA OFFICE SYSTEMS CORPORATION (COPYLANDIA), a corporation duly organized and existing under the laws of the Philippines with its branch office address at GF22 & LGS08 Megatower residences, Sandiko St. Salud Mitra Barangay Baguio City represented herein by its authorized Representative, **Mr. LAURENTE T. MUÑOZ** (hereinafter called the "Supplier").

WITNESSETH

 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any



5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.


