CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of _____, 2023 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

GAKKEN (PHILIPPINES) INC. a corporation duly organized and existing under the laws of the Republic of the Philippines with principal office address at #156 Pantal East, Dagupan City, Pangasinan, La Trinidad, Benguet represented herein by its Duly Authorized Representative **GIAN VINCENT R. NAVARRO**, herein referred to as the **"SUPPLIER"**

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly **Lot 3 of the Project "Supply, Delivery and Installation of Three (3) Lots of Office Data Center Equipment, Upgrade of Existing CCTV Security System and ICT Equipment for the DepEd- CAR Regional Office"** and has accepted a Bid by the **"SUPPLIER"** for the supply of those goods and services in the sum of **TWO HUNDRED SEVENTY- SIX THOUSAND PESOS ONLY (276,000.00 Php)**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **Lot 3 of the Project "Supply, Delivery and Installation of Three (3) Lots of Office Data Center Equipment, Upgrade of Existing CCTV Security System and ICT Equipment for the DepEd- CAR Regional Office"** and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

The date of delivery of the goods and ancillary services shall be within forty-five (45) calendar days from the receipt of Notice to Proceed (NTP) In consideration for the sum of **TWO HUNDRED SEVENTY- SIX THOUSAND PESOS ONLY (276,000.00 Php)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the following Office Equipment in accordance with his/her/its Bid:




