 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



In consideration for the sum of **FOUR HUNDRED THOUSAND SIX HUNDRED SEVENTY-NINE PESOS (P 400,679.00) Only** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid. Attached is a faithful reproduction of the BAC-TWG Arithmetical Evaluation indicating the Description of items, Unit price, and Quantity/unit of *the said goods and services included in this contract made an integral part hereof by incorporation as "Annex A"*.
5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
