DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**.

"GENESIS AUTO CORP." a corporation duly organized and existing and by virtue of the laws of the Republic of Philippines with business address at KM 108, Maharlika Highway, Sumacab Este, Cabanatuan City, Nueva Ecija represented herein by its Authorized/ Designated Representative **RHEINALINE PARULAN**, herein referred to as the **"SUPPLIER"**

WITNESSETH

WHEREAS, "THE ENTITY" invited Bids for Certain goods and ancillary services, particularly the **RE-BIDDING OF SUPPLY AND DELIVERY OF MOTOR VEHICLES FOR THE NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES (Lot 2)** and has accepted a bid by the **"SUPPLIER"** for the supply of those goods and services in the sum of **THREE MILLION EIGHT HUNDRED THOUSAND PESOS (P3, 800, 000.00)**; hereinafter called "THE CONTRACT PRICE".

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

5. The SUPPLIER shall be liable for LIQUIDATED DAMAGES for the delay in its performance in the amount equal to one-tenth of one percent (0.001) of the cost of the goods scheduled for delivery for every day of delay until the goods are finally delivered and accepted by the PROCURING ENTITY. DepEd Shall deduct the liquidated damages from any money due or which may become due to the Supplier, or collect from any warranties or securities posted by the Supplier, whichever is convenient. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
6. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.

Recommendation

The BAC-TWG went to the registered address of Genesis Auto Corp. at Cabanatuan City to ensure that the bidder is a legitimate business and to evaluate their capability in the delivery of the project.


The original copies of the legal, technical, and financial documents submitted during the opening of bids were validated, verified, and seen in their original form.


The offered vehicle, the County New Breeze, was not available at the showroom during the post-qualification. A brochure was presented for reference instead as well as the other variant of the minibus which is the County New Breeze extra long with reclining seats, to check the conformity of the offered vehicle to the technical specifications in the bid document.

Although some of the technical specifications were not part of the production of the offered vehicle, the bidder made an assurance to meet the required technical specifications of the vehicle to be delivered if the project is awarded to them. It includes a luggage lamp, a step lamp, a front-seat cup holder, a fire extinguisher, and a high-mount stop lamp. The offered vehicle also cannot include a rear-window defogger, instead, the bidder offered to add a rear-view camera.

Considering the aforementioned, it is established that Genesis Auto Corp. is a legitimate business, and the offered vehicle, the Hyundai Mini Bus County New Breeze meets most of the technical specifications. Specifications that are not included in the production of the vehicle that can be added do not affect the vehicle's general performance. It is then recommended to award the project Rebidding of Supply and Delivery of Motor Vehicles for NEAP-Baguio (Lot 2) to Genesis Auto Corp. and be declared as the Single Lowest Responsive Bidder.


