

In consideration for the sum of **SEVENTEEN MILLION TWENTY-SEVEN THOUSAND SEVEN HUNDRED SIXTY-SEVEN PESOS AND EIGHTY CENTAVOS (₱ 17,027,767.80)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid. 5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.


