LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **“PROCURING ENTITY”**

WITNESSETH

The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2024 LEARNING TOOLS AND EQUIPMENT FOR TECHNICAL-VOCATIONAL-LIVELIHOOD (LTE-TVL) WITH 10 LOTS – LOT 8** and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

3. The contract duration or completion period shall be within **Within 90 Calendar days upon receipt of the Notice to Proceed (NTP)**;
 4. In consideration for the sum of **One Million One Hundred Fifty-eight Thousand Eight Hundred Fifty-five Pesos (₱1,158,855.00) only** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid.

5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.


