LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

RIANELLA PRINTING PRESS with a principal office address at No. 6 Serafica Building, Upper Ferguzon Road, Baguio City represented by its proprietor, **ROMEO T. ONG**, herein referred to as the "SUPPLIER"

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly "SUPPLY, PRINTING AND DELIVERY OF READING RESOURCES (STORYBOOK PACKAGES) FOR READING PROGRAM FOR DEPED-CAR" and has accepted a Bid by the "SUPPLIER" for the supply of those goods and services in the sum of TWO MILLION SEVENTY-TWO THOUSAND ONE HUNDRED NINETY-THREE PESOS AND SEVENTY-FIVE CENTAVOS ONLY († 2,072,193.75);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


- In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read SUPPLY, PRINTING AND DELIVERY OF READING RESOURCES (STORYBOOK PACKAGES) FOR READING PROGRAM FOR DEPED-CAR and construed as integral part of this Agreement, viz.:
 - . Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the

bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- The contract duration or completion period shall be within sixty (60) calendar days upon receipt of Notice to Proceed;
- 4. In consideration for the sum of TWO MILLION SEVENTY-TWO THOUSAND ONE HUNDRED NINETY-THREE PESOS AND SEVENTY-FIVE CENTAVOS ONLY (₱ 2,072,193.75) or such other sums as may be ascertained, "SUPPLIER" agrees to provide the goods and services in accordance with his/her/its Bid. Attached is a faithful reproduction of the BAC-TWG Arithmetical Evaluation indicating the Description of items, Unit price, and Quantity/unit of the said goods and services included in this contract made an integral part hereof by incorporation as "Annex A".
- 5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
