CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of _____, 2024 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **“PROCURING ENTITY”**

-And-

RIANELLA PRINTING PRESS with a principal office address at No. 6 Serafica Building, Upper Ferguzon Road, Baguio City represented by its proprietor, **ROMEO T. ONG**, herein referred to as the **“SUPPLIER”**

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly **“SUPPLY, PRINTING, AND DELIVERY OF READING RESOURCES (STORYBOOK PACKAGES) FOR THE READING PROGRAM OF DEPED-CAR”** and has accepted a Bid by the **“SUPPLIER”** for the supply of those goods and services in the sum of **FOUR MILLION FIVE HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED SIXTY PESOS AND TWENTY CENTAVOS ONLY (P 4,587,460.20);**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **SUPPLY, PRINTING, AND DELIVERY OF READING RESOURCES (STORYBOOK PACKAGES) FOR THE READING PROGRAM OF DEPED-CAR** and construed as integral part of this Agreement, *viz.:*
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents

3. The contract duration or completion period shall be within **sixty (60) calendar days upon receipt of Notice to Proceed;**
4. In consideration for the sum of **FOUR MILLION FIVE HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED SIXTY PESOS AND TWENTY CENTAVOS ONLY (₱ 4,587,460.20)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the following goods and services in accordance with his/her/its Bid:


