LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

-And-

**ROMAN INSTRUCTIONAL MEDIA RESOURCES INC.** with a principal office address at 36 Anahaw St. Veterans Village, Proj. 7, QC represented by its proprietor, **PARALUMAN R. ROBLES**, herein referred to as the **"SUPPLIER"**

WITNESSETH


