LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly "THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2025 LEARNING TOOLS AND EQUIPMENT FOR TECHNICAL-VOCATIONAL-LIVELIHOOD (LTE-TVL) WITH 4 LOTS FOR DEPED-CAR - LOT 3" and has accepted a Bid by the "SUPPLIER" for the supply of those goods and services in the sum of ONE MILLION FOUR HUNDRED NINETY EIGHT THOUSAND FIVE HUNDRED PESOS (** 1,498,500.00);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. The contract duration or completion period shall be within 90 calendar days from the receipt of the Notice to Proceed;
- 4. In consideration for the sum of ONE MILLION FOUR HUNDRED NINETY EIGHT THOUSAND FIVE HUNDRED PESOS (**) 1,498,500.00) or such other sums as may be ascertained, "SUPPLIER" agrees to provide the following goods and services in accordance with his/her/its Bid; (The items, unit, quantity, unit cost and brand are identified in the bid evaluation report of the BAC-TWG)

The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
