CONTRACT AGREEMENT

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **“PROCURING ENTITY”**

-And-

VRMV TECH SOLUTIONS CORPORATION and VENNMARK CORPORATION (a Joint Venture Agreement Notarized by Atty. Robles G. Calabias with Doc. No. 131, Page No. 27 Book IV S.2022), both corporations are duly organized and existing under the laws of the Philippine with office address at No. 8 Diamond Subdivision, San Luis Village, Baguio City represented herein by its authorized Representative, **Mr. VENN RYAN P. AQUINO (hereinafter called the “JOINT VENTURE”)**.

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly **Lot 2 of the Project “SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) LOTS OF VARIOUS INFORMATION COMMUNICATION AND TECHNOLOGY EQUIPMENT AND OFFICE EQUIPMENT FOR THE NATIONAL EDUCATORS’ ACADEMY OF THE PHILIPPINES IN BAGUIO CITY”** and has accepted a Bid by the “JOINT VENTURE” for the supply of those goods and services in the sum of **ONE MILLION, FIVE HUNDRED FIFTY-EIGHT THOUSAND, EIGHT HUNDRED EIGHTY PESOS ONLY (PHP 1, 558, 880.00)**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;

The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **Lot 2 of the Project “SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) LOTS OF VARIOUS INFORMATION COMMUNICATION AND TECHNOLOGY EQUIPMENT AND OFFICE EQUIPMENT FOR THE NATIONAL EDUCATORS’ ACADEMY OF THE PHILIPPINES IN BAGUIO CITY”** and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

- 3. The contract duration or completion period shall be **within 60 calendar** days from receipt of the Notice to Proceed;
- 4. In consideration for the sum of **ONE MILLION, FIVE HUNDRED FIFTY-EIGHT THOUSAND, EIGHT HUNDRED EIGHTY PESOS ONLY (Php 1, 558, 880.00)** or such other sums as may be ascertained, "**JOINT VENTURE**" agrees to provide the following Office Equipment in accordance with his/her/its Bid:





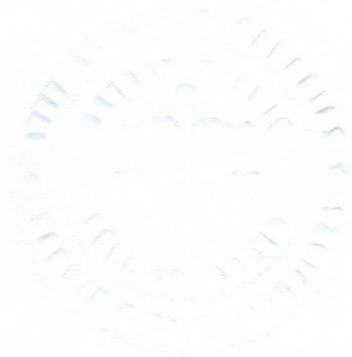
