7.a. Advance Payment: Advance payment may be made to the contractor in an amount not exceeding fifteen percent (15%) of the contract price upon the submission to and acceptance by DepEd-CAR of an irrevocable letter of credit of equivalent value from a commercial bank, a bank guarantee or a surety bond callable upon demand, issued by a surety or insurance company duly licensed by the Insurance Commission and confirmed by DepEd-CAR and shall be repaid by the contractor by an amount equal to the percentage of the contract price used for the advance payment.

7.b.1. The Contractor may submit a request for payment for Work accomplished. Such request for payment shall be verified and certified by DepEd-CAR's Representative/Project Engineer.

7.b.2 The first progress payment may be paid to the Contractor provided that at least fifty percent (50%) of the work has been accomplished as certified by DepEd-CAR's Representative.

7.b.3. Progress payments are subject to retention of ten percent (10%). Such retention shall be based on the total amount due to the Contractor prior to any deduction and shall be retained from every progress payment until fifty percent (50%) of the value of Works, as determined by DepEd-CAR, are completed. If, after fifty percent (50%) completion, the Work is satisfactorily done and on schedule, no additional retention shall be made; otherwise, the ten percent (10%) retention shall again be imposed using the rate specified therefor.

7.b.4. The total "retention money" shall be due for release upon final acceptance of the Works. The Contractor may, however, request the substitution of the retention money for each progress billing with irrevocable standby letters of credit from a commercial bank, bank guarantees or surety bonds callable on demand, of amounts equivalent to the retention money substituted for and acceptable to DepEd-CAR, provided that the project is on schedule and is satisfactorily undertaken. Otherwise, the ten (10%) percent retention shall be made. Said irrevocable standby letters of credit, bank guarantees and/or surety bonds, to be posted in favor of the Government shall be valid for a duration to be determined by DepEd-CAR and will answer for the purpose for which the ten (10%) percent retention is intended, i.e., to cover uncorrected discovered defects and third party liabilities.

7.b.5. On completion of the whole Works, the Contractor may substitute retention money with an "on demand" Bank guarantee in a form acceptable to DepEd-CAR.

8. The Contractor shall pay DepEd-CAR for liquidated damages (LD), and not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay. DepEd-CAR shall deduct the liquidated damages from payments or any money due or which may become due to the Contractor under this Contract and/or collect such liquidated damages from the retention money or other securities posted by the Contractor whichever is convenient to DepEd-CAR. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of this Contract, DepEd-CAR may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances;

- k) Notice of Award of Contract and the Bidder's conforme thereto;
- l) Other contract documents that may be required by existing laws and/or DepEd-CAR.

3. The contract duration or completion period shall be **One Hundred Twenty (120) calendar days** reckoned on the "start date"; The "start date" is the date of receipt of the Notice to Proceed by the Contractor;

4. In consideration of the Contract Price mentioned herein to be paid by DepEd-CAR to the Contractor, the Contractor hereby covenants to execute and complete such works and to remedy all defects therein in conformity in all respects with the provisions of this Contract;


5. DepEd-CAR hereby covenants to pay the Contractor in consideration of the execution and completion of such works and the remedying of all defects therein, the Contract Price or such other sum may become payable under the provisions of this Contract at the times and in the manner prescribed by the Contract;

6. The Contract Price shall be paid to the Contractor, through the Government disbursement procedures subject to the payment, retention money and warranty provisions in the General Conditions of Contract, the Special Conditions of Contract, and the IRR of 9184;

7. The method and conditions of payment to be made to the contractor under this contract shall be as follows:


7.a. Advance Payment: Advance payment may be made to the contractor in an amount not exceeding fifteen percent (15%) of the contract price upon the submission to and acceptance by DepEd-CAR of an irrevocable letter of credit of equivalent value from a commercial bank, a bank guarantee or a surety bond callable upon demand, issued by a surety or insurance company duly licensed by the Insurance Commission and confirmed by DepEd-CAR and shall be repaid by the contractor by an amount equal to the percentage of the contract price used for the advance payment.

7.b.1. The Contractor may submit a request for payment for Work accomplished. Such request for payment shall be verified and certified by DepEd-CAR's Representative/Project Engineer.

7.b.2 The first progress payment may be paid to the Contractor provided that at least fifty percent (50%) of the work has been accomplished as certified by DepEd-CAR's Representative.

7.b.3. Progress payments are subject to retention of ten percent (10%). Such retention shall be based on the total amount due to the Contractor prior to any deduction and shall be retained from every progress payment until fifty percent (50%) of the value of Works, as determined by DepEd-CAR, are completed. If, after fifty percent (50%) completion, the Work is satisfactorily done and on schedule, no additional retention shall be made; otherwise, the ten percent (10%) retention shall again be imposed using the rate specified therefor.


7.b.4. The total "retention money" shall be due for release upon final acceptance of the Works. The Contractor may, however, request the substitution of the retention money for each progress billing with irrevocable standby letters of credit from a commercial bank, bank guarantees or surety bonds callable on demand, of amounts equivalent to the retention money substituted for and acceptable to DepEd-CAR, provided that the project is on schedule and is satisfactorily undertaken. Otherwise, the ten (10%) percent retention shall be made. Said irrevocable standby letters of credit, bank guarantees and/or surety bonds, to be posted in favor of the Government shall be valid for a duration to be determined by DepEd-CAR and will answer for the purpose for which the ten (10%) percent retention is intended, i.e., to cover uncorrected discovered defects and third party liabilities.

7.b.5. On completion of the whole Works, the Contractor may substitute retention money with an "on demand" Bank guarantee in a form acceptable to DepEd-CAR.

The Contractor shall pay DepEd-CAR for liquidated damages (LD), and not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay. DepEd-CAR shall deduct the liquidated damages from payments or any money due or which may become due to the Contractor under this Contract and/or collect such liquidated damages from the retention money or other securities posted by the Contractor whichever is convenient to DepEd-CAR. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of this Contract, DepEd-CAR may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances;




9. The Contractor shall post a Warranty Security valid for One (1) year from the date of Certificate of Final Acceptance issued by DepEd-CAR, in any of the following amounts and forms:

5% of the Contract Price	Cash; or Letter of Credit issued by a Universal or Commercial Bank; if issued by a foreign bank, the LC shall be confirmed or authenticated by a Universal or Commercial Bank.
10% of the Contract Price	Bank Guarantee confirmed by a Universal or Commercial Bank.
30% of the Contract Price	Surety Bond callable upon the demand issued by the GSIS or any Surety or Insurance Company duly certified by the Insurance Commission.


