CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of _____, 2022 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **“PROCURING ENTITY”**

-And-

“HEXACOM ENTERPRISES” a duly registered sole proprietorship organized under the laws of the Philippines with principal office address at Stall 1, Adivay Building, Bonifacio Street, Baguio City represented herein Owner, herein referred to as the **“SUPPLIER”**

WITNESSETH

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;

 - i. Philippine Bidding Documents (PBDs);

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any


