

SECURITY SERVICES FOR THE FOR THE REGIONAL OFFICE FOR CY 2022

CONTRACT AGREEMENT

THIS AGREEMENT made this 27th day of January 2022 between **DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED-CAR)** of the Philippines (hereinafter called "the Entity") of the one part and **SIDEKICK FORCE INVESTIGATION AND SECURITY SERVICES, INC.** of Baguio City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Security Services for the Regional Office for CY 2022 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **PHILIPPINE PESO ONE MILLION ONE HUNDRED NINETY EIGHT THOUSAND ONE HUNDRED NINETY EIGHT PESOS & 60/100 (Php1,198,198.60)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


3. In consideration for the sum of **PHILIPPINE PESO ONE MILLION ONE HUNDRED NINETY EIGHT THOUSAND ONE HUNDRED NINETY EIGHT PESOS & 60/100 (Php1,198,198.60)** or such other sums as may be ascertained, Sidekick Force Investigation & Security Services, Inc. agrees to provide Security Services with Six(6) Security Personnel in the DepEd- CAR Regional Office located at Wangal, La Trinidad, Benguet on three (3) regular shifts per day everyday including Saturdays, Sundays and Holidays with two (2) security guards per shift and in accordance with his/her/its Bid.
4. The DepEd- CAR agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. Together with the billing statement, Sidekick Force Investigation & Security Services, Inc. shall submit photocopies of remittances for Pag-IBIG, PhilHealth and SSS premiums of the guards assigned to DepEd-CAR.
6. Should the PAG-IBIG contribution be increased from ₱100.00 to ₱150.00, the difference (₱ 50.00) shall be borne by Sidekick Force Investigation & Security Services, Inc.


