CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of NOV 13 2024 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by **ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director** referred to as the **“PROCURING ENTITY”**

-And-

ESM LEARNING ENTERPRISES with a principal office address at G14 Porta Vaga Mall, Session Road, Baguio City represented by its proprietor, **ESMERALDA E. DEE**, herein referred to as the **“SUPPLIER”**

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly **“REBIDDING OF THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2024 SUPPLEMENTARY LEARNING RESOURCES (SLRs) TO THE SCHOOL LIBRARY HUBS UNDER LOTS 2, 3, 4, 8, 14, 15, AND 16 FOR DEPED-CAR - Lot 8”** and has accepted a Bid by the **“SUPPLIER”** for the supply of those goods and services in the sum of **Six Hundred Forty-four Thousand and Two Hundred Pesos (₱ 644,200.00)**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **REBIDDING OF THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2024 SUPPLEMENTARY LEARNING RESOURCES (SLRs) TO THE SCHOOL LIBRARY HUBS UNDER LOTS 2, 3, 4, 8, 14, 15, AND 16 FOR DEPED-CAR - Lot 8** and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. The contract duration or completion period shall be within **Sixty (60) calendar days upon receipt of Notice to Proceed;**
4. In consideration for the sum of **Six Hundred Forty-four Thousand and Two Hundred Pesos (P 644,200.00)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid. Attached is a faithful reproduction of the BAC-TWG Arithmetical Evaluation indicating the Description of items, Unit price, and Quantity/unit of *the said goods and services included in this contract made an integral part hereof by incorporation as "Annex A"*.
5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.


