**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO SIDEKICK FORCE INVESTIGATION & SECURITY SERVICES, INC. FOR THE REBIDDING ON THE PROVISION OF SECURITY SERVICES FOR THE DEPED CAR FOR FY 2024**

**ABC: P2, 255, 000.00**

**WHEREAS**, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request for the above stated project with an ABC of **P2, 255, 000.00** (Two Million and Two Hundred Fifty-Five Thousand Pesos only);

**WHEREAS**, the DEP-ED CAR Regional posted the Invitation to Bid in the PhilGEPS, DEP-ED CAR RO, and bulletin boards continuously from November 14, 2023 to December 5, 2023 at 1:30 PM and held its pre-bid conference on November 21, 2023, 10:30 AM at the Office of the Assistant Regional Director which was attended by prospective bidders;

**WHEREAS**, pursuant to Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act," and its Implementing Rules and Regulations (IRR), the DEPED- CAR Regional Office through its Bids and Awards Committee (BAC), conducted the opening of bids for the above project on December 5, 2023, at 1:31 PM at the Office of the Assistant Regional Director, Wangal, La Trinidad, Benguet;

**WHEREAS, SIDEKICK FORCE INVESTIGATION AND SECURITY SERVICES, INC**, having acquired the bidding documents and demonstrating commendable punctuality in the submission of their proposals, have had its submission duly accepted by the BAC;

**WHEREAS**, upon opening of the bids, the BAC initially assessed the bid documents of Toyota using a non- discretionary pass or fail criteria and after having assessed that the above bidders complied with the legal, technical, and financial documents, the BAC subsequently opened the financial bid offers (Envelope 2). The findings are summarized as follows:

**WHEREAS**, after a detailed and thorough bid evaluation, the post-qualification was subsequently conducted on December 18, 2023 at 317 Luy Wing Building, Magsaysay Avenue, Baguio City, being the single, lowest calculated bidder;

**WHEREAS**, during the presentation of the post-qualification report on December 19, 2023, at the Office of the Assistant Regional Director, the Bids and Awards Committee (BAC) moved for the recommendation to award the contract to SIDEKICK FORCE INVESTIGATION AND SECURITY SERVICES, INC, being the single lowest calculated responsive bidder of the project;

NOW, THEREFORE, we, the members of the Bids and Awards Committee (BAC) of the Department, on the basis of the foregoing findings by the TWG, RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) as follows:

1. To Award the Contract for the **REBIDDING ON THE PROVISION OF SECURITY SERVICES FOR THE DEPED CAR FOR FY 2024**, being the Single Lowest Calculated Responsive Bidder, with a contract amount of **₱2,168,132.76**; and,
2. To recommend for approval by the Regional Director, DepEd-CAR Regional Office the foregoing findings.
