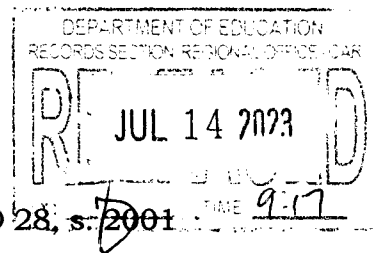

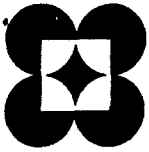

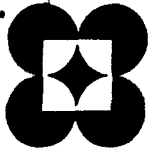
As a valued member of the CWIC, we would like to invite you or your representative/s in joining the event.
