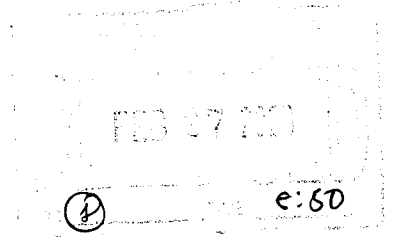

The PhilSys is established to give valid proof of identity to all citizens. Additionally, it intends to increase financial inclusion, prevent fraud and misrepresentation, and advance corporate efficiency.

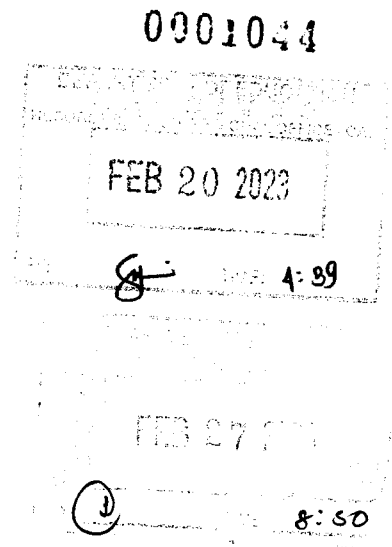

**SUBJECT: Request for Assistance in the Dissemination of Philippine Identification System (PhilSys) School Registration Campaign**

Dear Director Cariño:

*Our Warmest Greetings!*

The Philippine Statistics Authority (PSA) is mandated as the primary agency in implementing RA 11055, otherwise known as the Philippine Identification System. The PhilSys is established to give valid proof of identity to all citizens. Additionally, it intends to increase financial inclusion, prevent fraud and misinterpretation, and advance corporate efficiency.

The PSA committed to register and issue 92 million Philippine Identification (PhilID) cards by the end of June 2023. As of January 31, 2023, the PSA has registered 76.27 million Filipinos to the Philippine Identification System (PhilSys). To close the gap, PSA field offices should register at least 125,000 individuals per day to cover the remaining 15.73 million potential registrants. Majority of the remaining unregistered individuals are children aged 5 to 15 years old.

In an effort to achieve the goal that every citizen should have a national ID especially the children, several mechanisms, including registration of school age students, have been put in place.

On this regard, we are seeking your assistance in the dissemination of the Philippine Identification System School Registration Campaign in the different schools. This is a strategy that addresses the low registration turnout during school registration due to lack of awareness of students and parents on the required supporting documents for PhilSys registration and its benefits for children. The Chief Statistical Specialist of the Provinces will be coordinating to the different schools to cascade pertinent information to teachers, parents, and students through the conduct of school/class briefings/orientations and provision of information, education, and communication materials.

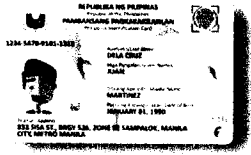

Printed by the Bangko Sentral ng Pilipinas (BSP) alongside a letter containing your PSN and delivered to registered persons by the Philippine Postal Corporation (Post Office).

### PhilID



Printed at PhilSys Registration Centers or downloaded in the registered person's mobile device.

### ePhilID

**There is a PhilID allocated for each registered person.**



The ePhilID is a proactive strategy of the PSA that will allow more Filipinos to immediately enjoy the benefits of being PhilSys-registered.

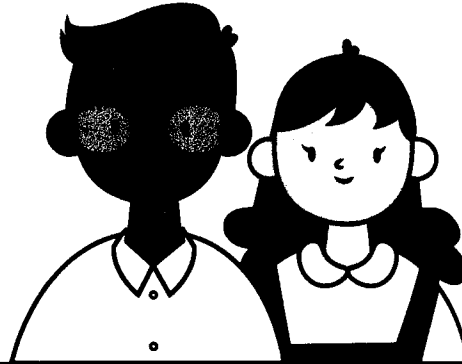

### PHILIPPINE IDENTIFICATION SYSTEM

Ang Philippine Identification System (PhilSys) na naitatag sa pamamagitan ng Republic Act No. 11055 ay ang single national identification system para sa lahat ng Pilipino at resident aliens.

## Paano mag-register?

1



Ipakita ang supporting documents sa Registration Kit Operator (RKO).

2



Ipa-validate ang demographic data at magpakuha ng biometric information, kabilang ang fingerprint at iris scanning.

3



I-review at i-confirm ang naibigay na demographic data at biometric information.

4



I-claim ang transaction slip na ibibigay at itago itong mabuti. Kailangan itong ipakita oras na i-deliver ang PhilID at sa pagkuha ng ePhilID.

## Supporting Documents

Para sa mga magulang na nais ma-register ang kanilang anak o sa mga estudyanteng nais magpa-register sa PhilSys, ipakita lamang ang original copy ng alinman sa mga sumusunod na dokumento:

- **School ID o Certificate of Enrollment** na may front-facing photograph, full name, birth date, at permanent address
- **Parental Consent/Authorization Letter**, bilang patunay na pinapayagan ang bata na mag-register kung sakaling hindi masasamahan ng magulang o guardian ang bata sa araw ng registration

### Paalala:

Kung hindi masasamahan ang bata ng magulang o guardian sa araw ng registration, kailangan ng pirmedong consent form upang maka-register ang bata sa PhilSys.

**Narito ang iba pang supporting documents na maaaring ipakita:**

### PRIMARY DOCUMENTS:

1. PSA-issued Certificate of Live Birth AND one (1) government-issued identification document which bears full name, front-facing photograph, and signature or thumbmark;
2. Philippine Passport or ePassport issued by the Department of Foreign Affairs (DFA);
3. GSIS or SSS-issued Unified Multi-purpose Identification Card (UMID); or
4. Land Transportation Office (LTO)-issued Student's License Permit or Non-Professional/Professional Driver's License

1. PSA-issued Certificate of Live Birth/National Statistics Office (NSO)-issued Certificate of Live Birth with Birth Reference Number (BreN);
2. Local Civil Registry Office (LCRO)-issued Certificate of Live Birth;

4. PSA-issued Certificate of Foundling;
5. Integrated Bar of the Philippines (IBP) Identification Card;
6. Professional Regulatory Commission (PRC) ID;
7. Seaman's Book;

9. Senior Citizen's ID;
10. SSS ID;
11. Pantawid Pamilyang Pilipino Program (4Ps) ID;
12. License to Own or Possess Firearms (LTOPF);

14. Police Clearance/ID;
15. Solo Parent's ID;
16. Person with Disability (PWD) ID;
17. Voter's ID;
18. Postal ID;

Ang **PhilSys Number (PSN)** ay ang unique at permanent na identification number ng registered persons sa PhilSys Registry.

Ang **PhilSys Card Number (PCN)** ay ang number na makikita sa PhilID o ePhilID na magagamit sa mga transaksyon.
