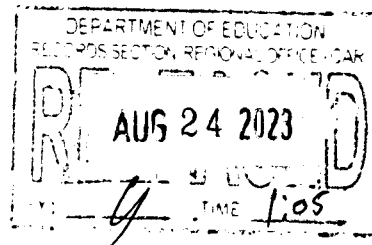

SUBJECT : Conduct of an Online Survey on the Evaluation of the  
Implementation of Research Management Guidelines (DO 16, s. 2017)

In 2017, the Department of Education issued the **Research Management Guidelines (RMG)** through the DepEd Order 16, s.2017 which aims to guide DepEd across all governance levels in the management and conduct of research initiatives to further promote and strengthen the culture of research in basic education. With the policy, research managers across all governance levels were able to conduct different initiatives that supported the researchers in conducting research. The RMG was also amended through DepEd Order 26, s.2021 to ensure the efficient continuity of the research management processes during the pandemic. After the 6-year implementation of RMG, and as stipulated in its provision on monitoring and evaluation, the Planning Service - Policy Research and Development Division (PS-PRDD), as the policy owner, will conduct a policy review/evaluation.

As part of its data gathering activities, the PS-PRDD will deploy an **online survey** to gather inputs and data relative to the evaluation activities. The survey specifically aims to assess the:

- a. responsiveness of the RMG for research managers and in the conduct of research for DepEd researchers;
- b. usefulness of RMG to research managers and researchers to deliver their required outputs; and
- c. efficiency and effectiveness of RMG as support to researchers and as guide to Research Managers.

The survey will employ a *convenience and voluntary sampling considering representation across all governance levels* and the different strategies of research management. It will also consider the differences in the training and technical assistance received by researchers in the conduct of their research.

In this regard, the Regional Office - Policy, Planning and Research Divisions (RO-PPRDs) are requested to disseminate the online survey questionnaire to the target research managers and researchers who conducted research from 2017 onwards which were evaluated by research

committee regardless of fund source (i.e Basic Education Research Fund, Special Education Fund), in Schools Division Offices (SDOs) and schools, to wit:
