**GRADE 10 TECHNOLOGY AND LIVELIHOOD EDUCATION (TLE) TRAINING OF TEACHERS**

1. Pursuant to DepEd Memorandum No. 38, s. 2015, Entitled "**GRADE 10 TECHNOLOGY AND LIVELIHOOD EDUCATION NATIONAL TRAINING OF TRAINERS (TLE NTOT)**" conducted at Tagaytay International Convention Center (TICC) Tagaytay City last April 28 to May 1, 2015. Relative hereto, the division offices are requested to conduct the Mass Training of Grade 10 TLE teachers either May 29, 30 & 31, 2015, to give time to other teachers to attend this TLE training. The Mass training aims to familiarize the participants on the following topics:
  - a. Updates on the K to 12 Basic Education Program;
  - b. Classroom Based Assessment;
  - c. Learning Standards, Content Standards, Performance Standards and Learning Competencies;
  - d. Teaching Strategies;
  - e. Walkthrough on grade 10 TLE CG, LM & TG.
2. The Division TLE supervisors/Coordinators shall prepare the division memorandum, attached the training matrix and list of participants, copy furnish the Regional office as reference in the monitoring and evaluation.
3. The Division offices can collect reasonable registration fee to cover the training cost and other incidental expenses chargeable against Division funds/School funds and other available sources, subject to the usual accounting and auditing rules and regulations, while the reproduction of Learning Materials and Teaching Guides will be charged to the regional funds.
