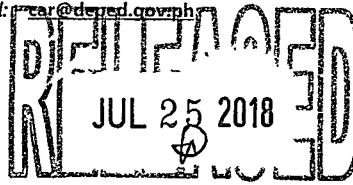

**SUBMISSION OF DATA ON MOTHER TONGUE BASED-MULTILINGUAL EDUCATION (MTB-MLE)**
