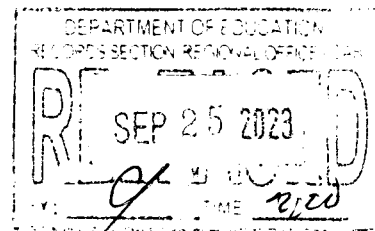

**REGIONAL TRAINING OF PSDSs, SCHOOL HEADS AND NEW ALS TEACHERS
 ON THE IMPLEMENTATION OF ALS - BATCH 2**

1. The Department of Education - Cordillera Administrative Region, through the Curriculum and Learning Management Division (CLMD) will conduct a **Regional Training of Public Schools District Supervisors, School Heads and New ALS Teachers on the Implementation of Alternative Learning System - Batch 2** on October 10 - 13, 2023 at El Cielito Hotel, 50 North Drive, Baguio City.

2. The activity aims to:
- orient PSDSs, School Head and new ALS teachers on the salient features of the ALS Act and its Implementing Rules and Regulations (IRR);
 - define the roles and responsibilities of different governance levels in the implementation of Alternative Learning System PPAs; and
 - establish a stronger linkage between the DepEd regional and field offices in the implementation and delivery of ALS programs.

3. Participants to the activity are PSDSs and School Heads directly supervising ALS teachers and new ALS teachers with no training on ALS Law (RA 11510). The breakdown of participants is shown in the table below:
