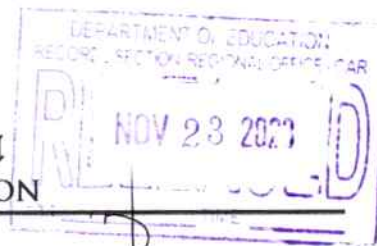

1. The Department of Education-Cordillera Administrative Region (DepEd-CAR) through the Curriculum and Learning Management Division (CLMD) will be conducting a **Workshop on the Preparation of Learning Resources for the Blind cum Quality Assurance and Printing of Summative Assessment for the Partially Blind** at Newton Plaza Hotel, Baguio City on November 27-29, 2023.
