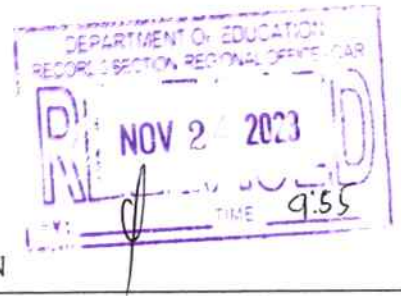

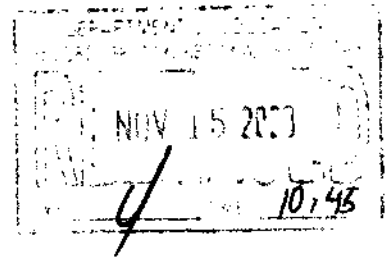

In observance to the 31st National Children's Month, with the theme: "Healthy, Nourished, Sheltered: Ensuring the Right to Life for All," the Department of Education Cordillera Administrative Region through the Education and Services Division (ESSD) will be conducting a training workshop titled "Capacity Building on Child Protection Concerns" on November 27-29, 2023 at H100 Ecolodge, Baguio City.
