**CONDUCT OF TELECONFERENCING/WEB CONFERENCING TO DRAFT THE
 REGIONAL POLICY ON GENDER RESPONSIVE AND NON-DISCRIMINATORY
 STUDENT DISCIPLINE MANUAL (GRaNdSDisM)**

1. To continuously ensure the effective and efficient provision of Legal Services to all women and men stakeholders, female and male learners in DepEd CAR, the Office of the Regional Director through the Legal Unit will conduct its 2nd quarter interface with SDO Key Personnel providing Legal Services cum Drafting of the Gender Responsive and Non-Discriminatory Student Discipline Manual (GRaNdSDisM) as scheduled following the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, and to maintain precautionary measures and health standard protocols of the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases;

Last April 30, the 1st Quarter Interface of RO and SDO Key Personnel providing Legal Services cum Drafting of the Gender Responsive and Non-Discriminatory Student Discipline (GRaNdSDisM) Manual was conducted through a teleconference/web conference accommodating 31 participants from the different schools division offices gathering important inputs and suggestions;
3. Hence, to come up with a draft Regional Policy Guidelines to be presented to Regional Policy Review Committee in preparation for the opening of classes on August, a regional teleconferencing/web conferencing will be conducted on May 27, 2020;
