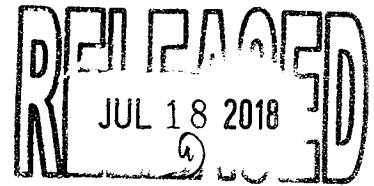

REITERATION OF DO 51, s. 2015 re: GUIDELINES ON THE IMPLEMENTATION OF THE SENIOR HIGH SCHOOL (SHS) PROGRAM IN EXISTING PUBLIC JUNIOR HIGH SCHOOLS (JHSs) AND INTEGRATED SCHOOLS (ISs), ESTABLISHMENT OF STAND-ALONE PUBLIC SHSs, AND CONVERSION OF EXISTING PUBLIC ELEMENTARY AND JHSs INTO STAND-ALONE SHSs

1. This office reiterates the strict implementation of DO 51, s. 2015 re: Guidelines on the Implementation of the Senior High School (SHS) Program in Existing Public Junior High Schools (JHSs) and Integrated Schools (ISs), Establishment of Stand-Alone Public SHSs, and Conversion of Existing Public Elementary and JHSs into Stand-Alone SHSs.
2. Division Review and Evaluation Committee (DREC) and Public Elementary and Secondary School Heads intending to apply for integration, conversion, or offer senior high school courses are advised to follow strictly the guidelines stipulated in the said order.
3. Attached is the Annex A of DO 51, s. 2015 on the Process Flow and Timeline of application.
4. Further, track, strands and specializations to be offered by the schools applying for SHS Program should be aligned to the need of the community. Thus, the Local Development Plan of the barangay/municipality/city should be the basis of identifying courses to be offered.
5. Compliance and immediate dissemination of this memorandum is desired.
