GUIDELINES ON THE UTILIZATION OF THE DOWNLOADED 2018 FUNDS FOR CAR FOR THE EARLY LANGUAGE, LITERACY, AND NUMERACY PROGRAM FUNDS: PROFESSIONAL DEVELOPMENT COMPONENT

To: **Schools Division Superintendents**
All Divisions

1. The Department of Education, (DepEd, CAR) issues the **Guidelines on the Utilization of the Downloaded 2018 Funds for CAR for the Early Language, Literacy, and Numeracy Program: Professional Development Component**. These guidelines shall cover the expansion of the professional development component of the program described in DepEd Order Nos. 12, s. 2015, 18, s. 2017 and 24, s. 2018 entitled Guidelines on the early Language, Literacy, and Numeracy Program: Professional Development Component.
2. The program aims to develop in Filipino children the literacy and numeracy skills, and attitudes, which will contribute to lifelong learning. With this, it is the goal of the Department to improve the literacy and numeracy skills of learners from kindergarten to Grade 3 following the K to 12 Basic Education Curriculum by establishing a sustainable and cost-effective professional development system for teachers.
3. The Downloaded Fund amounting to **1,200,000.00** shall be used for the efficient and effective **monitoring and evaluation** of the continuous conduct of the Learning Action Cells (LACs) in the total number of schools per division.
